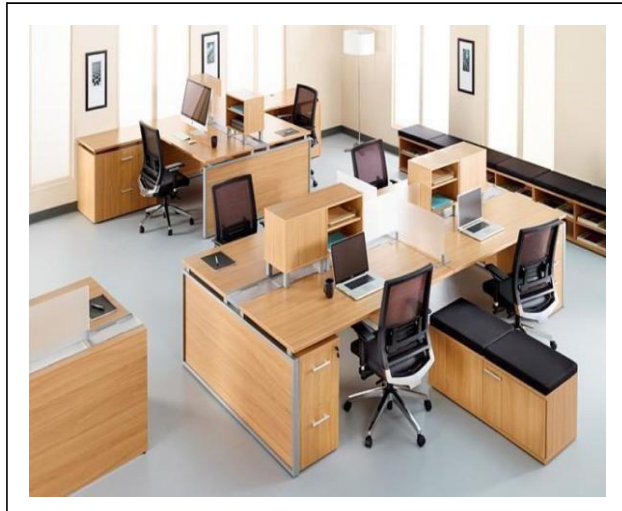

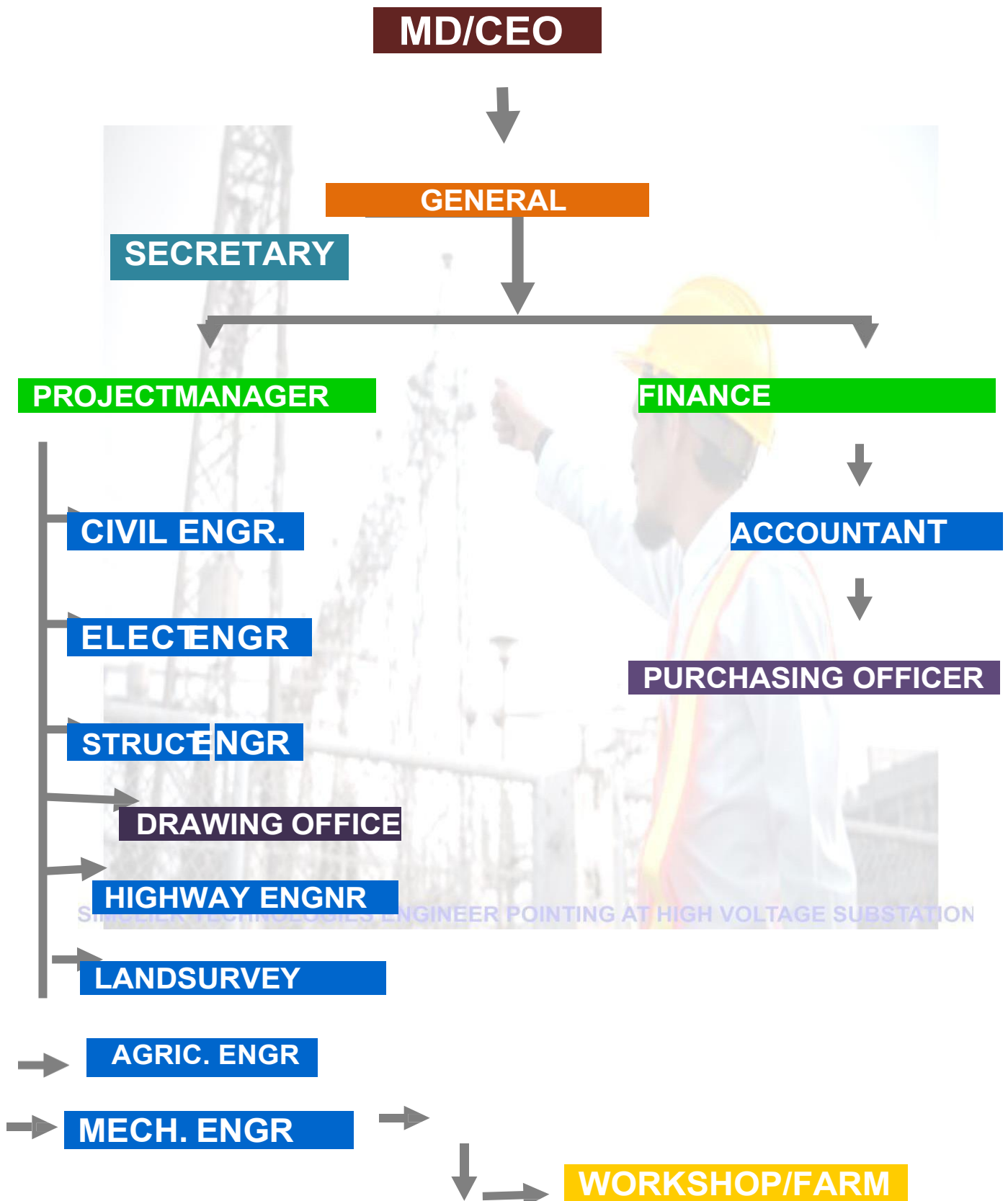




ORGANOGRAM
